1. The Chairman called the meeting to order at 7:03 pm.

## 6. Jermel gave Director's Report:

- a. This year's 4<sup>th</sup> of July event was held on Main Street and we had approximately 12,000 people at this year's event. The JD Cobb Band and Blaze of Glory band performed beginning at 5:00 pm. A Community feature this your was the acknowledgement of Marquise Goodwin; who won the Olympic Trials in the long jump with 27 ft. 4 inches in Eugene, Oregon and will now represent The USA. He is head to London for the Olympic Games and has a great chance to win the Gold Medal.
- b. Median bed updates have begun on Hwy 66. Rock has been added and some drought tolerant plant material will be added to complete the project.
- c. Upcoming Main Street Events—Movies on Main @ dusk on September 7<sup>th</sup>, 14<sup>th</sup>, and 21<sup>st</sup>.
- d. The Department accreditation process slowed during the month of July. It is Parks and Recreation month and the peak of our operation. Currently city staff is analyzing recreation programming,



park maintenance procedures and risk management practices. During the month of August there will be a joint workshop held with the City of Desoto for City staff.
