Ordinance: ORD-026-18

AN ORDINANCE OF THE CITY OF ROWLETT, TEXAS, AMENDING THE CODE OF ORDINANCES, CITY OF ROWLETT, TEXAS, BY AMENDING DIVISION 3 ("PARK FACILITIES") OF ARTICLE II ("RULES AND REGULATIONS") OF CHAPTER 42 ("PARKS AND RECREATION") TO REPEAL SECTION 42-101 RELATING TO LIMITATIONS ON THE USE OF TENNIS COURTS AND RESERVING SECTION 42-101 FOR FUTURE EXPANSION; PROVIDING A REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Rowlett, Texas, hereby finds and determines that ordinances should be kept in line with day-to-day operations and that it is important to keep up with industry trends; and

WHEREAS, the Council further finds that limitations on the use of City tennis courts are no longer practical and should be repealed as provided for herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROWLETT, TEXAS:

SECTION 1: That Division 3 ("Park Facilities") of Article II ("Rules and Regulations") of Chapter 42 ("Parks and Recreation") of the Code of Ordinances, City of Rowlett, Texas, be and is hereby amended to repeal Section 42-101 ("Tennis") in its entirety, without repeal, amendment or change to any other section or part of Division 3, and to reserve Section 42-101 for future use and expansion.

SECTION 2: That all ordinances of the City of Rowlett in conflict with the provisions of this ordinance be and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3: That if any section, paragraph, sentence, subdivision, clause, phrase or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of this ordinance or any other provision of the ordinances of the City of Rowlett.

SECTION 4: That this ordinance shall take effect immediately from and after its passage and the publication of the caption as the law and charter in such cases provide.

At a meeting of the City Council on September 4, 2018 this Ordinance be adopted. The motion carried by the following vote:
